**Memorandum  
of Intent on the establishment of the Platform of Non-Governmental  
Organizations of the Caspian countries**

“The Caspian House” This Memorandum of Intent on the establishment of the Platform of Non-Governmental Organizations of the Caspian countries “The Caspian House” (hereinafter referred to as the Memorandum) was signed between:

1. Non-Governmental Organization “Assistance to Development of Public Relations” represented by its Chairperson Shelale Arif kyzy Gasanova
2. International Union of Non-Governmental Organizations “Eurasian Peoples’ Assembly” represented by Deputy Secretary General Stanislav Lvovich Korolev
3. Non-Governmental Organization “EcoForum Kazakhstan” represented by its Chairperson Svetlana Vladimirovna Mogilyuk
4. Enterprise of the Public Organization “Tebigi Kuvvat” represented by its Director Berkeli Kadirovich Atayev (hereinafter referred to as the Parties)

**The Parties have concluded this Memorandum on the following:**

**Article 1. Subject of the Memorandum**

1.1. The subject of this Memorandum is the establishment of partnership relations and the development of long-term and effective cooperation between the Parties in the form of a Coalition aimed at implementing projects and initiatives to create the Caspian House, long-term and systematic information support for the virtual portal [caspianhouse.info](http://caspianhouse.info) and the "Virtual Museum of the Green Economy of the Caspian Countries", joint regional educational events, thematic programs, international conferences, etc.;

1.2. The Parties intend to implement cooperation on the basis of equality, goodwill, respect and trust, based on the generally accepted practice of

international cooperation of Coalitions of non-governmental organizations;

1.3. In the process of implementing this Memorandum, activities are carried out in accordance with the current legislation of the countries to which the Parties that signed the Memorandum belong, as well as the Charter of the signatory parties;

1.4. The conclusion of this Memorandum does not bind the Parties with any legal obligations, does not entail the emergence of financial obligations. If the latter is necessary, the Parties shall conclude separate agreements;

1.5. Each Party undertakes not to make public statements without prior agreement with the other Parties on issues of cooperation and the activities of the Caspian House within the framework of this Memorandum.

**Article 2. Areas of cooperation between the Parties** Within the framework of this Memorandum, the Parties have agreed to take joint actions to address the following tasks:

2.1. Development and adoption of the Regulation on the environmental community of the Caspian countries "The Caspian House"

2.2. Development of the Concept for the formation and development of environmental thinking of the public;

2.3. Regular updating of information on environmental problems and prospects of the Caspian countries on the portal [caspianhouse.info](http://caspianhouse.info);

2.4. Development of a long-term environmental agenda for the civil society of the Caspian countries;

2.5. Mutual participation of the Coalition members in forums, conferences, seminars and other similar events organized by the Parties;

2.6. Implementation of joint projects on environmental issues and other activities agreed upon in accordance with this Memorandum;

2.7. Drawing up a Program of events to develop cooperation between the Parties in the form of the Coalition. The Program may become an integral part of the Memorandum after its adoption by the Parties;

2.8. Joint drawing up of a calendar of meetings and discussions of current issues, topical events, planned events with the aim of exchanging experience and coordinated activities to develop the ideas of the Caspian House.

2.9. Annual (in accordance with Article 7) review of the progress in implementing the directions of the Memorandum and determining additional directions and forms of cooperation.

### **Article 3. Operational Interaction**

3.1. The Parties will determine contact persons who will promptly cooperate and carry out internal coordination for the purpose of systematic and consistent implementation of the tasks provided for in this Memorandum.

3.2. The Parties shall regularly exchange information on the progress and results of the implementation of current tasks.

### **Article 4. Confidentiality**

4.1. The Parties may not transfer to a third party any information or document created on the basis of the provisions of this Memorandum without the consent of the Parties.

4.2. The transfer of confidential information to other parties, publication or other disclosure of information may be carried out only with the mutual written consent of the parties, except for cases stipulated by law.

### **Article 5. Resolution of Disagreements**

Any disagreements that may arise during the interpretation or application of this Memorandum shall be resolved through negotiations and consultations between the parties.

### **Article 6 Amendments and Additions**


By mutual agreement of the parties, any amendments and additions may be made to this Memorandum. Such amendments and additions will be formalized in the form of separate protocols, which shall be an integral part of this Memorandum and shall enter into force in accordance with the provisions of Article 7.

### **Article 7. Duration and Termination of the Memorandum**


This Memorandum of Understanding shall enter into force on the date of its signing and shall be valid for 3 (three) years from that date. It shall be automatically extended for the next term unless one of the parties sends the other party a written notice of its intention to cancel it at least 1 (one) month prior to that.

Signed in Baku on November 19, 2024, in four original copies, each in the English language, all texts being equally authentic.


